The ITES-3S IDIQ has a \$12.1 billion ceiling and a POP of 5 base years and 4 individual option years, for a total of 9 years.	Long-term planning for large-scale program requirements

Upon completion of an approved Justification & Approval (J&A) document by the CO/ordering activity, sole-source awards may be initiated directly through the CHES/ITES-3S website without further approval

### Sole Source Under ITES-3S

- If you do not have an account with the CHES IT e-mart you must first register in order to gain access to the RFP Manager. <https://chess.army.mil> (Click on "cancel Certification request")
- Click on the Registration button in the upper right-hand corner of the front page
- Fill out the account information form with your email address and select "Register"
- You will need to login to access the RFP process via the home page. After log in, you will see your name and last login in the top-right corner of the IT e-mart.
- Hover over "RFx" on the Main Menu then click "Request for Proposal" from the drop down
- To create an RFP from any RFx page, hover over the "RFP -Services" button and select "Create".
- Select ITES-3S from the Programs drop down menu.
- For an American Systems "sole source" selection, (needs to meet the exceptions as defined in FAR 16.505 (b) or DFARS 216.505-70) scroll down to "W52P1J-18-D-A091: American Systems" and highlight this selection only. To select all vendors, click the "Select All" option.

Follow the remaining prompts to enter the RFP information as well as attach your supporting documentation. Questions regarding these guidelines and procedures for placing orders against the contracts should be directed to CHES. Questions of a contractual nature should be directed to the PCO, Army Contracting Command - Rock Island (ACC-RI).
